ATTACHMENT to Proposal F09 P0002-A

BYLAWS: Article XI, § 11.3, ¶ 12, p. 54 to add:

There shall be one year added to the Western RD's 2007-2010 term to facilitate the new election cycle pursuant to F09 P002 – A such that the next Western RD election is in 2011. This is a one-time addition to that existing term only and shall not otherwise affect the current terms and term limits as set forth in § 11.3, ¶ 11 of this Article.
