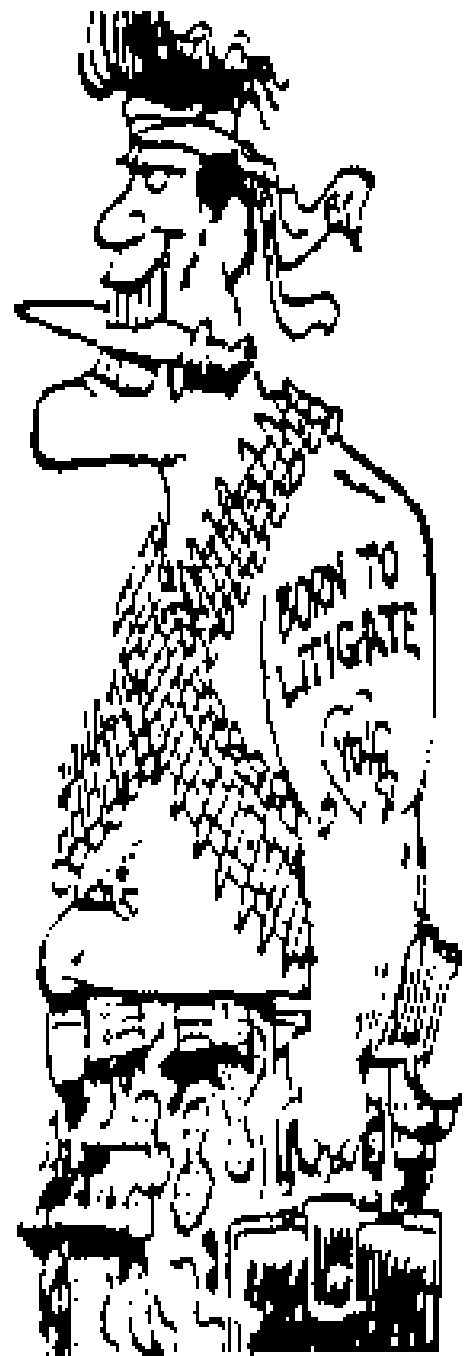
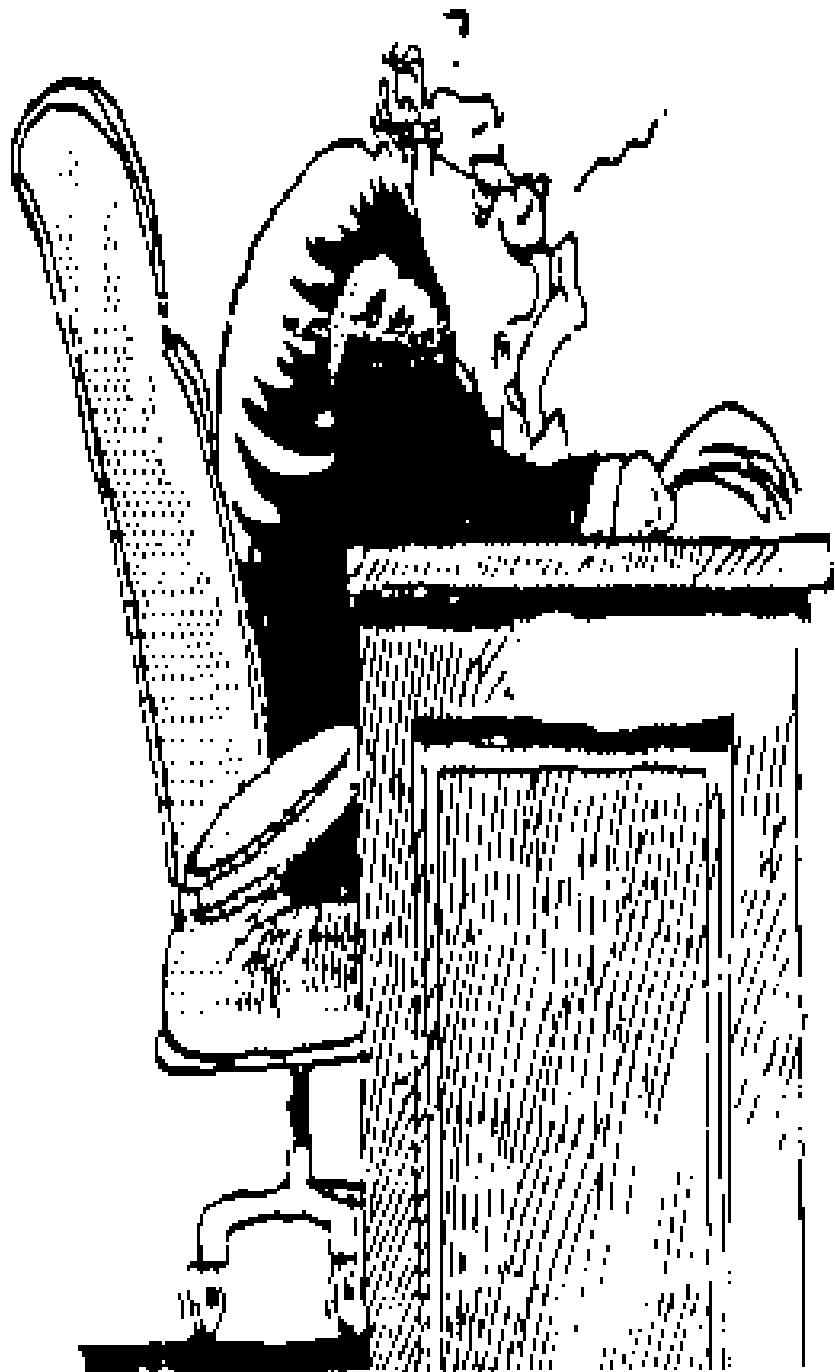
- **36 USC 152703. - Purposes**
- The purposes of the corporation are -
 - (1) **to promote, in every way, patriotic, scientific, educational, and civic improvement activities and public safety in skiing**, by such means as the dissemination of information and the formation of volunteer local patrols consisting of competent skiers trained in first aid **for the purpose of preventing accidents and rendering speedy assistance to individuals sustaining accidents**; and
 - (2) to solicit contributions of money, services, and other property for, and generally to encourage and assist in carrying out these purposes in every way.

Release Language Awareness

- I, _____, am aware that skiing and snowboarding and other ski patrol activities are HAZARDOUS activities and involve many RISKS and DANGERS including, ...
- snow grooming equipment, snowmobiles or other vehicles, equipment or structures; impact or collision with other skiers; negligence of other skiers, other patrollers and; **negligence on the part of ABC Resort and its agents, officers, owners and employees**

Express Assumption of All Risks

- In consideration of the Resorts allowing me to participate in their Ski Patrol as a Volunteer, to use the Resorts' related equipment, area facilities and premises, and for the additional benefits provided to me as a Volunteer Ski Patroller, which may include but is not limited to: free skiing and free or reduced rate accommodations, **I hereby expressly assume and accept any and all risks and dangers associated with my participation in skiing, snowboarding and other activities at the Resorts including, but not limited to serious personal injuries, death and property damage**

- In further consideration, I agree to **Release, Hold Harmless, Indemnify and Defend** The Resort from and against any and all claims, suits, actions, losses and damages that I have or perceive myself to have against the Resort, including but not limited to:
